To be counted, all mailed ballots must be received by us, The HOA Election Guys, Inc., by 5:00 p.m. on January 15, 2025. Ballots may also be hand-delivered to us on January 16, 2025, before the start of the special meeting.

This Special Meeting of the Members is being held to vote on the recall of the entire board of directors. If you are in favor of the recall, you will vote Yes on the first section of the enclosed ballot. If you are opposed to the recall, you will vote NO in the first section of the ballot. Both sections of the ballot should be completed even if you are opposed to the recall.

- Should the recall PASS, the members will then elect FIVE (5) board directors
- Should the recall FAIL, the current board members will retain their seats for their originally elected terms

In order to PASS, the recall must be approved by a majority of a quorum of the members, where quorum is defined as 25% of the membership, or 14 members. Once quorum is met, a majority of the votes cast must be cast in favor of the recall for it to pass.

If the recall is approved and the election for new directors proceeds, the candidates who will appear on the ballot are: Perry Bennett, Gavin Dorman, Tunisia Offray, Maria Vallarta, and Tisha Washington. Cumulative voting is permitted in this election. Accordingly, you can cast all of your votes for one candidate or divide your five votes among the candidates as desired. Fractional voting is not permitted.

Per LOG-HOA Bylaws 5.1, one of the directors will be elected solely by the votes of the commercial owners and one of the directors will be elected solely by the votes of the residential owners.

For the meeting and election to be held, a quorum of the membership must return a ballot, or attend the meeting in person.

The LOG-HOA Bylaws define a quorum as "25%" of the voting power of the LOG-HOA, or 14 members.
